MEMORANDUM OF UNDERSTANDING (MoU)

Between

SPM IAS Academy, Guwahati

And

Bihpuria College, Bihpuria, Lakhimpur

This Memorandum of Understanding (MoU) is made and entered into on this [],
by and between:

SPM IAS Academy, having its registered office at Times Square Mall, RGB Baruah Road,
Zoo Road, Guwahati, Assam, hereinafter referred to as "SPM IAS",

AND

Bihpuria College located at Bihpuria, Lakhimpur, Assam, hereinafter referred to as
"Bihpuria College."

Both parties are hereinafter individually referred to as a "Party" and collectively referred to
as the "Parties".

1. Purpose

The purpose of this MoU is to establish a collaborative arrangement between SPM IAS
Academy and Bihpuria College to conduct academic activities such as seminars and exams
within the premises of Bihpuria College.

2. Scope of Collaboration

a) Admission of Students

1. SPM IAS Academy shall offer admission opportunities to interested students of
Bihpuria College into APSC/UPSC coaching program.
2. Admission shall be based on eligibility criteria as laid down by SPM IAS
ACADEMY.
3. A special concession will be given to the students whose parents are BPL card
holders.

b) Use of College Facilities

1. Bihpuria College agrees to provide necessary infrastructure support including
classrooms, seminar halls, and examination halls to SPM IAS for:
 - I. Conducting seminars, workshops, orientation programs, and mock tests.
 - II. Organizing weekly/monthly evaluations for enrolled students.
2. All such usage of college facilities will be scheduled in coordination with the
college administration to avoid academic disruption.

3. Responsibilities of SPM IAS Academy

- a) Provide qualified faculty and updated study materials after the admission.
- b) Organize seminars/workshops in the Bihpuria College campus.
- c) Maintain discipline and decorum while using college infrastructure.

4. Responsibilities of Bihpuria College

- a) Support in mobilizing and encouraging students to take part in the coaching programs.
- b) Provide necessary infrastructure and administrative support as per mutual agreement.
- c) Facilitate communication between students and the academy.

5. Financial Arrangement

- a) Fees shall be collected directly by SPM IAS Academy.

6. Validity and Termination

- a) This MoU is valid for an initial period of 3 years from the date of signing and may be renewed upon mutual consent.
- b) Either Party may terminate this MoU with 30 days' written notice, subject to the completion of any ongoing academic activities.

7. Dispute Resolution

In case of any dispute arising out of this MoU, both Parties shall attempt to resolve the matter amicably. Failing which, the dispute shall be subject to the jurisdiction of the competent courts in Guwahati, Assam.

8. Miscellaneous

- a) This MoU does not create any legal partnership, joint venture, or employment relationship between the parties.
- b) Any amendments to this MoU must be made in writing and signed by authorized representatives of both parties.
